In Fiscal Year 2005, Marian House served 176 residents (154 women and 22 children) for a total of 24,641 bed nights. In addition, 423 women in the greater community attended outreach seminars or participated in support groups related to coping with sexual abuse, sexual assault or domestic violence.

Added to the Marian House programs this year was a wellness initiative, which included a health education series, a weekly art class, individual debt reduction, and participation in the Maryland Food Bank.

Community service is viewed as an opportunity to give back to the community. Most of the women and staff volunteered to assist with the Stadium Place Playground construction. Women participated in the Lancer Club Walk for the Homeless, Justice Monday—an initiative of the Maryland Justice Coalition, Fast and Sleep at Loyola College, spring planting in the Marian House courtyard, and the 150th Anniversary Celebration of the Sisters of Mercy.

Shelter Plus Care housing is in its second year, and has placed 22 individuals. Sixteen adults and six children are now living in 13 permanent rental housing units. The residents pay 30% of their adjusted gross income, on fees that range from zero to \$500 a month. Two Shelter Plus residents have realized home ownership through the Habitat for Humanity program.

The aftercare program follows former residents as long as we are able to keep in contact. They receive home visits, greeting cards on special occasions and are able to attend workshops of interest. Topics have included tax advocacy, repairing and rebuilding credit, what to know about banking, and relationship building.

A just completed study of 131 former residents' finances shows:

- 62% prepare a monthly budget to plan their spending
- 55% have a checking account
- 59% have a savings account
- 41% have a habit of saving weekly or biweekly

In addition:

- 90% have not used illegal drugs or alcohol since departing from Marian House

In 2005 we published our first annual report, held our first annual fund raiser and purchased Holy Spirit school. We begin our 24th year full of hope and trust in our dreams for the future.

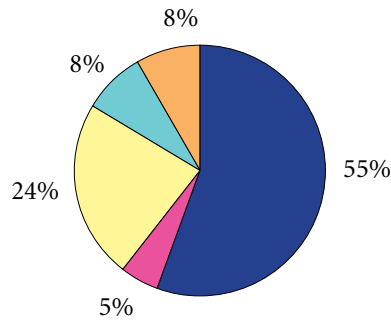

Total Public Support and Revenue **\$1,306,005**

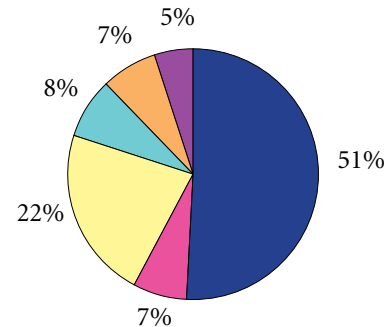

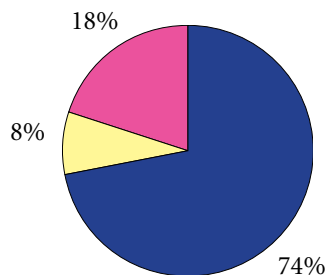

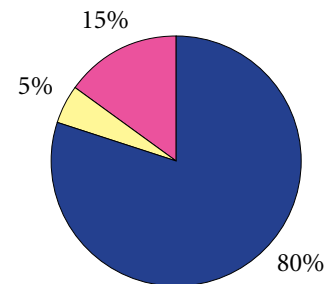

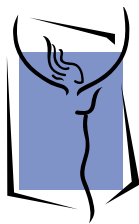




The Marian House Executive Directors
